AGAINST A SET OF STANDARDS THAT HAVE BEEN DEVELOPED INDEPENDENT OF INDUSTRY AND ARE BOTH HEALTH AND SCIENTIFICALLY BASED.

BUILDING BIOLOGY STANDARDS ACCOMMODATE FOR SENSITIVE INDIVIDUALS, FROM INFANTS TO THE ELDERLY AND THOSE IN POOR HEALTH, AND TAKE INTO CONSIDERATION FACTORS SUCH AS PROLONGED EXPOSURE, SYNERGIST AND CUMULATIVE EFFECTS.

It is a building biologists job not to add to the body's load (medicines and supplements), but to take away factors/toxicants that burden the body.
